THE NEED FOR STUDENT SUPPORT

Today, students are required to cover fees of £9,000 per year for tuition at Oxford and at most UK universities.* They also need to be prepared for living costs in Oxford of between £8,500 and £12,000 per year for accommodation, food and study costs. Students leaving Oxford today take with them an average debt of £44,000.**

The College (and the University) accept the best students, regardless of financial status or background and therefore offer generous bursaries and reduced fees. Oxford offers more generous support to those on a family income of less than £16,000 than any other UK university.

*This is the cost for UK and EU students. Students from outside the EU need to pay between £14415 and £21220 p.a. depending on the course. ** Sutton Trust.



THE OLD MEMBERS' GROUP

Old members can join this group 40 years after matriculation, so it comprises those who are retired or approaching retirement. The group's main purpose is to rekindle friendships from University days and keep abreast of College developments, by arranging social events for members. When we came up to Jesus students paid

no fees and many of us received generous grants for living expenses. Not so now. So, for us to support a bursary that enables a talented student with the potential to benefit from an Oxford education, which would be otherwise unaffordable, is an excellent cause.



THE OLD MEMBERS' GROUP BURSARY TARGET

The group would need to raise £100,000 (£81K plus gift aid) for a College endowed fund which would provide a bursary of £3,500 p.a. Matched funding from the College and the University would raise this to a maximum £7,900 p.a. with the first award in October 2021.

THE OLD MEMBERS' GROUP BURSARY

As its 450th anniversary approaches, the College is excited to launch the 2021 Campaign to raise funds to secure tutorial fellowships, scholarships and bursaries for generations to come. Our Old Members' Group has been contributing to the College for many years and have raised more than £300,000, which has supported over 150 students equally shared between men and women. The College has invited the Group to participate in the 450th anniversary fundraising. After meeting the College and discussion at the AGM, the committee concluded that the best approach was to support an undergraduate bursary. The College

is rightly proud of the diversity of its undergraduate community and a bursary that helped underpin this diversity was seen as an appropriate cause. Such a bursary could ensure a student of ability and potential whose family income would otherwise preclude an application, could come to Jesus with our support.

It is proposed that this bursary will be endowed, and known as The Old Members' Bursary in perpetuity, in acknowledgement of the donors supporting it. The College hopes to award the initial bursary in the anniversary year, 2021.

Our Group has led support for both undergraduates and postgraduates at College. The 450th anniversary in 2021 provides an opportunity to establish an undergraduate bursary in perpetuity for an able student coming from a low income family. To make the rewarding experience, most of us had, possible for another student is overwhelmingly worthwhile. Generosity springs from the heart and I hope that you will all wish to join with me in this endeavour according to your circumstances! Intriguingly one of our members suggested an anniversary donation of £2021 to match the year (equivalent of £33 per month for five years)! Whilst that would be a very generous offer whatever is possible for you will be recognised and valued as evidence of the Jesus College openness of heart and spirit!
